Serves as team leader overseeing personnel and reporting directly to department principal. Conducts effective performance evaluations and mentors those with less experience through formal and informal channels. Encourages more junior co-workers to take responsibility for their development within the company.

Produces contract agreements, fee proposals and project scope as required, creates and executes project work plans and revises as appropriate to meet changing needs and requirements. Identifies resources needed and assigns individual responsibilities. Manages day-to-day operational aspects of a project and scope, reviews deliverables prepared by team before passing to client. Prepares for quality assurance procedures by minimizing exposure and risks on project. Ensures project documents are complete, current, and stored appropriately. Ensures internal QA/QC procedures have been conducted by Principal/other Project Manager prior to submission.

Monitors team members' time and expense reports in a timely manner. Initiates and responds with clients and/or sub-consultants regarding scope, meetings, tasks, requests, invoicing, etc., as necessary. Analyzes project profitability, revenue and billing rates. Understands pricing model and billing procedures.

Manages day-to-day client interaction including setting and managing client expectations. Develops lasting relationships with client personnel. Communicates effectively with clients to identify needs and evaluate alternative business solutions. Seeks opportunities to increase customer satisfaction and deepen client relationships.
